The school shall not deny admission to any child for lack of proof of age and shall adhere to the provisions of section 15 of the Act of 2009. The School shall ensure:

No child admitted to the school shall be held back in any class or expelled from school till the completion of elementary education in the school; (ii)

No child shall be subjected to physical punishment or mental harassment; (iii)

No child shall be required to pass any Board examination till the completion of elementary education; (iv)

Every child completing elementary education shall be awarded a certificate as laid down under rule 23 of the Rajasthan Right of Children to Free and Compulsory Education Rules, 2011;

The teachers are recruited with minimum qualifications as laid under sub-section (1) of (vi) section 23 of Act of 2009;

Provided that the current teacher who, at the commencement of the Act of 2009 do not possess minimum qualifications, shall acquire such minimum qualifications within a period of 5 years, as per the provisions of the proviso to section 23 of the Act of 2009;

The teachers performs their duties specified under sub-section (1) of section 24 of the Act of 2009; and

(Viii) The teachers shall not engage himself or herself for private teaching activities.

The School shall follow the syllabus on the basis of the curriculum laid down by the appropriate
